

Advocacy Makes a Difference: What Every Driver Must Know now in audio format

What started out as advocacy to help ONE person access the study guide to take the Michigan driver's license test became a project to ensure access for people with reading disabilities all across the State of Michigan!

A customer, Andre, who wanted to study to get his driver's license was given the booklet What Every Driver Must Know from the local Secretary of State office. Andre has a learning disability that makes reading printed material difficult. Andre asked for the document in an audio format so he could listen to it. He was told it was only available in print. They suggested that he "find someone to read it to him" - it is 148 pages long!

Andre told staff at Disability Network about this. We found out that this same situation had been happening to other people with learning disabilities who need to study for the driver's license exam.

Disability Network Southwest Michigan staff knew

that under the Americans with Disabilities Act (ADA) the State of Michigan is held to a very high standard of accessibility for all citizens, yet the staff at the Secretary of State's office did not understand their ADA responsibility to provide this essential booklet in a way that was accessible to people with learning disabilities.

We worked with the State of Michigan's ADA Coordinator and the staff in the Office of Communications to get What Every Driver Must Know recorded in an audio format. This audio recording is now available free through the Braille and Talking Book Library, part of the National Library for the Blind and Physically Handicapped.
