

MESSAGE FROM THE PRESIDENT & CEO

FINANCIAL ACCOUNTABILITY

Disability Network Southwest Michigan's programs and services are a bridge to independent living and social change in the community. Throughout Fiscal Year 2016, we shared many examples of how we are bridging the gap for people with disabilities in Southwest Michigan through barrier removal in their lives and community. Lack of access to transportation, affordable/accessible housing, healthcare, employment and home access are common examples of barriers the majority of our customers experience on a daily basis. Our 2015-2016 Annual Report highlights the results of how our services impacted nearly 10,000 customers across eight counties; an increase of over 1,000 customers from the previous year.

As the number of customers we serve each year grows, our staff respond to their needs in new and innovative ways. As a result of the recent passing of the Workforce Innovation and Opportunity Act, staff have developed new programs and supports for youth with disabilities transitioning from school to be better prepared for accomplishing their next goals of employment or post-secondary education. Additionally, staff have engaged the communities we serve by educating people on cutting edge topics in the Disability Rights Movement such as disability pride, ableism, and employment disclosure, just to name a few.

Gaps in services for people with disabilities will continue to exist in the future as trends are demonstrating. Disability Network is focused on building relationships with Legislators, state partners, funders and donors to ensure we have the resources we need to bridge the gap for people with disabilities in Southwest Michigan.


